## 3. LAPD and LAFD Updates (5 minutes)

SLO Shea had no crime statistics with him at this time but he did say that statistics were still a little higher than last year, He referred to burglaries, car break-ins. He said that the area is getting hit a lot with car break-ins but that has leveled off and on the downhill.

SLO Shea mentioned that there was a violent crime a couple days prior on Bronson and Chula Vista. It involved someone walking north bounds on Bronson. The suspect/s asked the victim to give them their money. The victim then ran and the suspect/s ran the other direction.

SLO Shea said that as the entertainment district on Hollywood Blvd. has exploded it has caused the crimes around the blvd. to rise.

He said that the LAPD Hollywood Division is supposed to get 15 extra officers – referred to as the entertainment District - just for that little area. The officers are expected be brought in next month.

He referred people to LAPDonline.org for crime statistics.

Susan inquired about the status of the proposal to remove the no-parking signs on Bronson Ave. and was told that they would check with Capt Girmala.

The Depeche Mode concert on Thursday night – at Hollywood and Argyle – was mentioned because streets will be closed west of Vine, east of Argyle.

On Friday, April 24th, during the day there will be an Armenian Genocide demonstration at Hollywood/Western.

# **ADJOURNMENT**

Process for Reconsideration The Board may reconsider and amend its action on items listed on the agenda if that reconsideration takes place before the end of the meeting at which it was considered or at the next regular meeting. The Board, on either of these two days, shall: (1) Make a Motion for Reconsideration and, if approved, (2) hear the matter and take an action. If the motion to reconsider an action is to be scheduled at the next meeting following the original action, then two items shall be placed on the agenda for that meeting: (1) A Motion for Reconsideration on the described matter and (2) a [Proposed] action should the motion to reconsider be approved. A Motion for Reconsideration can only be made by a Board member who has previously voted on the prevailing side of the original action taken. If a Motion for Reconsideration is not made on the date the action was taken, then a Board member on the prevailing side of the action must submit a memorandum to the Recording Secretary identifying the matter to be reconsidered and a brief description of the reason(s) for requesting reconsideration at the next regular meeting. The aforesaid shall all be in compliance with the Ralph M.Brown Act.
