## PETITION TO PROTECT THE HOLLYWOOD MASTER PLAN ON THE 1900 BLOCK OF NORTH SAINT ANDREWS PLACE

We are sending you this petition in order to protect the integrity of the Hollywood Master Plan. The decades long effort of the Immaculate Heart High School to enlarge its parking lot northward on the 1900 Block of North Saint Andrews Place violates the Master Plan.

Recently we learned that the school is once again attempting to expand their parking lot. They tried to secretly purchase the home at 1912 North Saint Andrews Place, which is adjacent to their parking lot on the corner of Franklin and North Saint Andrews.

The owner of 1912 is an 81 year old conservatee and we were told that the court disapproved the attempted sale as a "sweetheart deal." The court appraised his property in June 1998 at \$290,000.00, but the school offered only \$250,000.00.

No one in the neighborhood knew about the attempted sale until after the court disapproved it and the Conservator was required to place a For Sale sign in the front yard.

Because the school wants to tear down the house and expand their parking lot, the neighborhood had a meeting and everyone on the street is opposed to any NON R-1 use for 1912 North Saint Andrews Place.

According to the neighborhood residents who lived here when the school constructed the first parking lot over thirty years ago, the school said they wanted the house for a faculty lounge and as soon as they bought the property, they tore down the house and put in a parking lot. History seems to be repeating itself.

Thus, we petition you three councilpersons to go on record opposing any Non-R-1 use for any property on the 1900 block of North Saint Andrews Place.

We petition you to go on record as opposing any and all non-R-1 use for the 1900 block of North Saint Andrews Place. We oppose <u>any non residential use</u> for the block whether it is a lounge for the school's faculty, classrooms, playground, or a parking lot.

In order to protect the integrity of the block, the ONLY ACCEPTABLE USE of 1912 North Andrews Place is a single family residence.
